

Student Publications Annual Term Subscription Promotion

Terms and Conditions

(Last updated on 9 April 2025)

1. This Student Publication Annual Term Subscription Promotion (“**Promotion**”) is organized by SPH Media Limited (“**SPH**”, “**us**”, “**we**”, or “**our**”).

2. Participation in this Promotion is subject to:

(a) the terms and conditions herein (the “**Specific T&Cs**”); and

(b) the Standard Subscription Terms and Conditions below (the “**Standard T&Cs**”)

(collectively, the “**T&Cs**”).

In the event of any conflict or inconsistency among the T&Cs, the Specific T&Cs shall prevail.

3. This Promotion is valid during the period commencing from 9 Dec 2025 to 31 Mar 2026 or such date as we may determine in our sole and absolute discretion (the “**Promotion Period**”).

4. Under this Promotion, sign-up for a new subscription to any of the subscription packages listed in the table set out in the Annex (the “**Package**”) and enjoy a 10% discount off the applicable subscription fees for the first year of your subscription (“**Promotional Subscription Fee**”). For further details of the available Packages and the relevant fees, please refer to the table in the Annex to these T&Cs below. Please note that subscriptions under this Promotion will be subject to a minimum subscription period of 1 year (“**Minimum Subscription Period**”).

5. After the Minimum Subscription Period, you may cancel your subscription to the Package in accordance with our Standard T&Cs. All amounts paid prior to the date of termination will be **strictly non-refundable**.
